Advance Care Directives

Kajinpa over 18 manu nyarrpa-kanpa mangu-nyanyi ngulaju kajikanpa nguju-mani Advance Care Directive (ACD).

Nyampu Advance Care Directive:

- Ngulaju legal document
- Ngulaju nyuntu-nyangu healthcare-kirli langu yangka nyarrpa nyarrpa wangkajaku accommodation, langungu marrda, manu personal affairs-iki.
- Manu nyampu langu Enduring Power of Guardianship, manu marrda Medical Power of Attorney, manu Anticipatory Direction documents.
- Lawa ngulaju cover maninja-wangu yangka finance-iji, manu property, manu legal affairs.
 - Yangka yarrda nyanyaku information-iki yangka nguju-maninjaku financial decisions, ngulaju-nyarngka “enduring Power of Attorney” fact sheet.

Ngula walku-manu Advance Care Directive:

- Ngulaju use-i manta yangka official Advance Care Directive form.
- Nyuntulu kajikanpa jana mani yapa jinta-kari langu manu parnu-langu yapa yangka nguju-maninjaku nyampu substitute decision-makers (SDMs).
- Nyuntulu yangka yirra-nyarrpa-nyarrpa yungunpa nyina nyuntu-nyangu future kulu.
 - Kajinpa yirrani maya details nyuntu-nyangu wishes-kirli, ngulaju nguju-nyayni nyuntu-nyangu SDM-iji yangka nyarrpa nyarrpa decision yungunpa nguju-mani-iki.
- Nyuntulu yangka yungunpa nguju-mani nyuntu-nyangu end-of-life directions.
- Ngulaju yungu sign-i mani yangka authorised witness-irli.
- Nyuntulu yungka jana certified copies nyuntu-nyangu SDMs-manu nyuntu-nyangu doctor-aku.
 - Ngulaju lawa ACD register-wangu.

Substitute Decision-Makers ngulaju:

- Yangka yalpi ngampurrpa-wangu yangka decision yungunpa nyuntulu nguju-mani-iki.
- Japirni yungungulu nyuntu nyuntu-nyangu wishes manu nyiya-ku kanpa ngampurrpa nyinami.
- Mirl-mirlparlu puray medical refusals (ngulaju nyampuju legally binding).
- Pulka-pinyi kanpa nyuntu-nyangu nyurru-warnu palka wishes, manu nyuntu-nyangu care manu protection.
- Nguju manta decisions ngula marrdanpa-nguju marnu (“Karriya nyuntu-nyanyu wiliyarla”).
