Guardianship and the public advocate

The Public Advocate ngula kalu nguju-mani South Australian Civil and Administrative Tribunal (SACAT) as a Guardian of Last Resort if:

- Yapa marrda mental incapacity kirli
- Ngulaju wankarru-kulangu accommodation, manu health decision yangka nguju-maninjaku.
- Ngulaju lawa yangka yapa-kari maninjaku.

Yapa yangka under guardianship ngulaj-kalu jana yirrani advocate/guardian, manu parnu guardian-wati yangka ngula kalu jana milyapinyi nyarrpa-nyarrpa yangka yimi pirdyirdi-maninjaku.

Guardian manu team wati kajik-kalu:

- Nguju mani decision-yapakuju
- Advocate yangka access-iki manu service-iki
- Promote coordination yangka service-iki
- Manu nguju-maninjaku communication manu conflict resolution, kaji yangka pirdyirdi yapa nyina.

SACAT kalu nguju-mani pirdyirdi japa yungu guardian-irli decision nguju-mani yangka nyampurra-ku:

- Accommodation-iki yangka yapaku living arrangement-iki
- Health yangka marrda yungunpa yirrani consent medical manu dental treatment-ikiji
- Yangka access-i maninjaku ngana Protected Person-iki nyina ngan-kulu, manu
- Yangka lifestyle appropriate support-iki, manu education-iki manu employment iki.

Full guardianship-iji ngulaju yangka guardian yangka. Ngula-kalu jana nyurnu murlparlu mardani manu decision wiri-kalu jana nguju-manu yapu nyurnu wiri-iki.

Ngula kalu decision yapaku nguju-mani, SACAT-irli manu guardian wati-irli ngulaju-kalu:

- Nyurnu-warnu manu jalangu wanu nyiya marrda.
- Yangka nguju-yapa nyampurra arrangement wati.
- Yangka yungu yapa nyurnu-yungulu murlpa-murlparlu nyanyi.
- Manu yapa yungulu pirdyird-irli mardani.

Guardian-irli kapi nyarrpa-nyarrpa information mani yapa-kulu:

- Yangka nyurru-wana yimi manu nyarrpa-nyarrpa ka-nyina
- Wishes yangka yungu nyarrpa-jarri
- Manu yangka assessments wati treatment-kirli manu yangka support maninjaku nyarrpa-nyarrpa
- Manu yangka pirdyirdi japa yungu nyina protection-kirli.

Guardian kapi information-wati mani nyampu-wana:

- Kaji-jana meet-i mani yapa ngula kalu ngampurrrpa nyina yangka yapa-kulangu care-kirli.
- Tunu-mani ngula kalu assessment report-wati.
- Ngula-kalu request-i mani information wati yangka write-i maninjala.
- Manu yangka ngula-kalu jana yapa yuru-nyanyi nyarrpa-nyarrpa-ka nyina manu kaji nguju japa ngampurrrpa jarri decision nguju-maninjaku.
- Manu family wati-irla manu friend-wati-irla wangkanjaku kaji ngampurrrpa jarri decision nguju-maninjaku ngula-ka active manu positive role mardani yapu-kulangu life-irla.

Kapi guradian-irli decision nguju-mani:

- Yirran-jala principles of the Guardianship Administration Act.
- Support-i mani yapa-kulangu lifestyle manu wishes yangka niyaku kaji ngampurrrpa-jarri nguju-maninjaku.
- Manu kalu jana pirdyirdi mani health manu wellbeing yapa nyurnuku.

Kajinpa ngampurrrpa wangu jarri decision-ngula nguju-manu delegated guardian-irli kajikanpa:

- Request review mani decision-kirli yangka senior staff-kirli Office of the Public Advocate (Wana information yarrda nyanyaku nyangka "OPA Complaints Policy").
- Manu nyangka assistance of an advocacy service.
- Yirraka SACAT nyampuku variation manu revocation-iki yangka Guardianship orders-iki.
- Yirraka-kala Guardianship Order-iki yangka review maninjaku senior members wat-irli SACAT-iki (nyarangka SACAT information-iki yangka Reviews manu Appeals-iki).

Nyampu Public Advocate ngulaju jinta-nyayni statutory officer, yangka accountable South Australian Parliament-iki ngulaju office-iji wurnturru South Australian Civil and Administrative Tribunal-kuju (SACAT).
