# Guardianship Orders

Kaji decision wati nguna yangka yapa mental incapacity-kirliki, South Australian Civil and Administrative Tribunal (SACAT) irli nguju manika Guardianship order.

Ngulaju Guardianship Order-iji:

- Ngulaju legal document
- Kaji-kangulu mani guardian panu-panu yungulu warrki-jarra mapirri manu marrda jinta-kari jinta-kari.
- Kaji kalu mani guardian yangka decision nguju-maninjaku yangka marrda accommodation-iki, manu health care-iki manu yangka lifestyle decision-iki.
- Manu kalu review-mani 3 years jangka ngula kalu SACAT-irli date nguju mani lawa expiry date nguju maninjakuju.
- Manu ngulaju kajika kalu nyanyi nyiya langungu marrda yangka yungulu changes nguju-mani yangka nyiya marrda, manu nyarrpa-nyarrpa.

A Guardianship Order ngulaju nguju maninja-warnu:

- Yalpi wangu marrda yangka family manu friend-wati maninjaku
- Lawa marrda yangka yapa wangu yangka health care decision nguju maninjaku.
- Support-i wangu yangka arrangement watirki marrda nguju-maninjakuju.
- Yapa marrda agree jarrinja-wangu yangka informal decision wat-irki.
- Lawa marrda Advance Care Directive yangka ready marrda nguju-maninjaku.
- Ngujuju yangka conflict decision-kirli manu decision-maker watikirli nguju maninjaku.

A guardian:

- Yapa marrda yipilji walalja manu marrda friend ngula-ka milyapinyi yapu nyurnu.
- Lawa paid carer wangu
- Yangka Public Advocate langu
- Yangka marrda consult jarri yapa-kulu
- Manu consult-jarri family-kirli manu marrda yapa-kari marrda yangka ngampurrpa kaji nyina yapa nyurnu yalpi maninjaku.
- Yangka pinangkalpa yapangku manu support agency-irl ka consult-i mani.
- Manu puranjaku instruction-wati nyampu Advance Care Directive.
- Manu yapa-kulangu wishes nyiya marrda murlparlu respect maninjaku.
- Manu yapa-kulangu cultural background respect-i maninjaku.
- Manu murlparlu pirdyirdi mardan-jaku.

The tribunal manu guardian wati ngulaju-kalu jana pulka-pinyi:

- Nyurru-wanu manu marrda jalang-jalangu wishes yapa kulu.
- Murlparlu yimi mardan-jaku yangka arrangement kirli.
- Yangka nguju pirdyirdi nyayni option wati murlparlu mardan-jaku yapa nyurnuku.
- Manu yapa-kulangu care murlparlu mardan-jaku manu protection.
